Students are trained based on new curricula in compliance with governmental requirements, national and European educational achievements and the current needs of professional practice.

The used equipment, information assurance of subjects and teaching staff establish conditions for high-level modern educational process.

Social workers are highly skilled, analytical and applied professionals performing a system of activities in assistance of vulnerable and disadvantaged individuals, families, groups and communities in order to help their socialization and integration. They are actively involved not only in the protection of their customers' rights, showing respect for their best interests and improving their quality of life, but also in the formation of a more humane and socially responsible society. With the increasing number of integrated social services including a clinical component, social workers tend to interact with health care professionals, physical therapists, occupational therapists, psychologists, educators etc. in multidisciplinary teams.

Social activities professional field has been accredited with the following majors: Social activities for *Bachelor's* educational and qualification degree (*full-time and extra-mural course of study*) and Clinical social work for *Master's* educational and qualification degree (*full-time and extra-mural course of study*).

The curriculum for Bachelor and Master Degree Programmes includes compulsory and optional subjects and enhanced practical training throughout the entire course of study in institutions with good practices. It provides an opportunity to learn a system of integrated knowledge, skills and values in key educational fields - Sociology and Social Policy Fundamentals and Methods of Social Work, Psychology, Human Medicobiological Development, Legal Sciences, Economics, and Social Activities Organization and Management, Informatics and Information Science, Foreign Language. A special theoretical and practical focus is put on the clinical component consisting of psychosocial and medico-social field. This allows training of qualified specialists and enabling them to practice effective and quality professional activity in certain work fields and engage in multidisciplinary helping activity.

Social workers have their professional career in municipal and regional structures of the Agency for Social Assistance, specialized municipal and regional administrations, within the State Agency for Child Protection, social services rendered within the community and by specialized institutions, hospitals for active treatment, mental health centres, centres for people with alcohol and drug problems, prevention information centres, imprisonment facilities, probation services, employment agencies, non-governmental organizations, carrying out social activities etc.

Graduating students, majoring in Social Activities Bachelor Degree Programme are entitled to continue their education in graduate programs and specializations within the respective professional and higher education fields. Graduating students, majoring in Clinical Social Work Master Degree Programme are entitled to apply to doctoral programs in the respective professional and higher education fields.

2. Conditions for admission to the degree "Bachelor" specialty "Social Activities".

To enroll in a specialty requiring candidates unless application of certain of the University entrance exam, have a high level of language skills and communication; humanistic, altruistic and prosocial value orientation; basic skills, attitudes and motivation to work with vulnerable groups of people in certain social and health status, ethno-cultural background, age, sexual orientation, etc..

3. Duration of training degree "Bachelor" specialty "Social Activities".

Training in the specialty of full-time study lasts 4 years (8 semesters) and part-time training - 5 years (10 semesters).

4. Aim and tasks of training degree "Bachelor" specialty "Social Activities".

4.1. Learning Objective

professional protection when violations of human rights; h / nature and characteristics of social work in the modern world; g / contemporary theories and models for social work concepts and approaches for integrating theory and practice; h / traditional and innovative techniques, methods and approaches to help people of different age and risk groups; and / organization and implementation of counseling, intervention case, crisis intervention and short-term psychotherapeutic approaches; k / profile of the social work profession (functional-role structure, fields and levels of occupation, value orientation, ethics, power configurations, professional personality); 1 / organizational and management structure and processes in the systems of social services and health care; m / essence and characteristics of social policy and health; n / effective communication strategies; o / methodology and methods of research in social work; s / use of modern information technologies in the field of social work

B. Students who complete their studies in a written state exam than the written development of a number of topics of an established questionnaire and decide a case (practical and attached component of the state exam). Depending on the nature, location and specifics of educational trends in education including hours of practical and applied training in order to ensure the integration of theory and practice, to ensure a high level of competence of students in their graduation and help their adaptation as young professionals in practice.

Abstract:

Course introduces students to the basic issues of sociology as a science that provides knowledge about the regularities in the development and functioning of social systems and society. The lecture course students acquire knowledge about the specific social interactions "human - society", "human - community" and "human - human" in various social systems transform these interactions according to role functions in different stratification. The trainees acquire skills in: sociological analysis of data collected by means of sociology on the role of the subjective factor in certain social systems and in society to use social technologies for the management of professional and social processes.

Course content:

The course includes the systemic problems of sociology as a science of society, the scientific status of sociology, the origin and development of sociology in the early twentieth century, the main trends of modern sociology, sociological theory of society, human communities, the main sociological structure of society, regional sociological structure of society, the family as a structural unit of territorial communities, social systems and personality, socialization of the individual, sociological analysis of labor, demography, social time, empirical and theoretical level of sociological knowledge, methodology and organization of the polls.

Teaching and assessment:

1. Way of conducting classes

Teaching is by through lectures, which includes information about contemporary sociology. For visualization of the lectures be used, if necessary, multimedia, interactive presentation system, results of research, etc., required to solve specific learning tasks.

2. Forms of continuous control

Conduct is current writing control topics. The results of the tests and the activity of individual students are assessed by the teacher during the semester. Scheduled to conduct one control work. Its results are evaluated and used in forming the final evaluation.

3. Conditions for certification of course

Visiting lectures is compulsory for students. The semester grade is obtained by regular and active participation in the learning process.

4. Forming the final mark for the discipline

The training ends with a written exam and an interview with the main problems of the curriculum. The final evaluation is formed as an average score of monitoring and evaluation of the written semester exam.

Abstracts

Lecture course on discipline occupies an important place in the specialized theoretical and applied training students from the specialty. Section introduces students to the anatomy and joints of the human nervous system, cardiovascular system, reproductive system. Training in general human pathology helps students acquire a basic idea of the mechanisms for the occurrence of structural and functional changes in cells and tissues that constitute the essence of general pathology processes.

3. Conditions for certification of the course

Abstract:

The course is a basic in the preparation of students in specialty. It presents and justifies social work in scientific, applied, vocational and practical and institutional aspects. It explores the questions of the historical development of social work, the content, the methodological, the constructive and the technological, the functional and the role, the professional, the activity and institutional specificity of social work.

Course content:

Students are introduced to theoretical and practical foundations of social work in its function of science, applied field, professional activity. The course consists of four relatively independent parts. In the first two of them to address problems of the history of social work, the general theoretical foundations and modern trends and perspectives in social work, models for implementation of social work. In the third and fourth section looks at the issues related to social work as a professional activity directions for implementation of social work in Bulgaria and specificity of the professional activities of the social worker there. For each section are provided in lectures, seminars and practical exercises.

Teaching and assessment:

1. Way of conducting classes

In the training process in the discipline using the methods: systematic presentation of the material (lecture), talk, discussion, role play training to acquire vocational skills, independent research (preparation of course work) and others. When necessary for visualization of the material using appropriate technical means. The theme of the course work is assigned/selected at the beginning of the semester and must be implemented as written paper in accordance with certain requirements by the end of the semester.

2. Forms of continuous assessment

Information on the level and quality of the students learned values, knowledge and skills obtained through prior, current and final monitoring and evaluation of student achievement. The emphasis is on cognitive activity and autonomy and individual responsibility of the students. The final evaluation of the student is the result of estimates derived from participation in all forms of learning activity and control - lecture, discussion and debate, role training, presentation and protection of course work, current and final control (final written semester exam). Monitoring and evaluation of students is carried out by method of the original lecturer. Extramural activity for students to realize through their preparations for seminars and workshops, and ongoing monitoring and final course assignments.

3. Conditions for certification of the course

Visiting lectures, seminars and practical classes and participation in the current control is the mandatory for the students. Semester of the course takes place only if regular and active participation in the learning process and the implementation of those requirements.

4. Forming the final mark for the discipline

The final assessment of the course is based on the basis of a methodology in monitoring and evaluation mechanism. In a certain proportion of assessments involving different activities (10%), preliminary and current control (20%) and final control of semester examination (70%). The final evaluation will be presented in accordance with the ESTC (European system of credit transfer).

Abstract:

The course is conducted to students enrolled in study program "Social activities". The purpose of the lectures is to familiarize students with the computer as a technical device as well as with the software products facilitating the daily work of the specialists in a variety of areas. The purpose of the practice sessions is to provide students with knowledge and skills for working with up-to-date software products applied in word processing, electronic spreadsheets and graphical systems. Students acquire knowledge and skills for operating with approved program systems for document processing, as adopted in the Regional Health Insurance Fund.

1. Course content:

Brief historical notes on computers' development. Characteristics of computer generations. Computer classification. Hardware and software. Operation systems - functions and problems. Operation systems with friendly graphic interface. Application word processing programs - essence, possibilities. Well-known word processing programs. Electronic tables. Local and global computer networks. Internet. Computer processing of medical and economical information. Databases. Statistical data processing.

2. Teaching and assessment:

Lectures are held 2 classes per a fortnight. Practice sessions are carried out on what has been taught during the lectures, so that students get familiar with relevant software applications. Students need to self-study the software products before the practice classes. The final grade is formed from the current assessment mark and the test result.
